- B. Remove shoes before entering jumpy.
- C. No flips are allowed.
- D. Jumpy must be vacuumed well at end of rental.
- E. Safety depends on ADULT SUPERVISION. As the lessee of the Jumpy Rental unit, safety is YOUR RESPONSIBILITY. Lessee agrees to provide adult supervision at all times during the term of the lease. If any questions on safety or operation should arise, don't hesitate to call us at the number below.
- F. No water, silly string, gum, candy, food, mud, excessive water or drinks are allowed in the jumpy unit at any given time.
- G. Neglect of the above terms could cause a cleaning charge of \$50 per jumpy unit. An invoice will be sent.
- H. Do not remove the jumpy unit from the original place of installation. Do not move jumpy unit close to a pool. If jumpy unit moves, push back to the original location.
- Should the jumpy unit deflate and the motor has stopped, remove all children. Check the extension cord and connection. If the motor continues to run, check the air intake on the side of the blower for any obstruction or blockage. Check the air tube for snugness and tighten if necessary. If problem can't be corrected, call the number below.
- J. Do not allow water hoses or water toys in or around the jumpy units. This poses the risk of electrical shock.
- K. A \$25 service fee will be imposed for all returned checks.
- L. Cancellation Policy We will provide a 100% refund if contract is cancelled PRIOR to set up. Refunds will not be available once set up has begun or been completed.
- M. Weather Policy We reserve the right to cancel rental contracts and refund money if we are concerned about the potential for unfavorable weather.
- N. If it rains on the jumpy unit, leave the jumpy unit in place with the blower running. The air flow prevents water from entering through the seams. However, if winds are threatening to blow the unit over, turn off the blower and let the unit collapse.
- O. Schools, churches, businesses and organizations shall carry, at their own expense, comprehensive general liability insurance coverage for all persons and activities and provide a certificate of such insurance naming South Central Minnesota Youth For Christ and Youth For Christ USA, Inc. as additional insureds. Schools, churches, businesses and organizations that hire Youth For Christ staff to oversee the jumpy unit during the rental period are exempt from providing a certificate of insurance.
- P. The Hold Harmless and Indemnification Agreement and Assumption of Risks is required to be signed by schools, churches, businesses, organizations, and individuals who are renting jumpy units.
- Q. RELEASE OF LIABILITY / TERMS OF LEASE: The lessee shall be in charge of the jumpy unit and fully responsible for the operation of the jumpy unit after receiving it. South Central Minnesota Youth For Christ is NOT responsible for injury sustained by the lessee or other persons using the jumpy unit. Lessee agrees to hold harmless South Central Minnesota Youth For Christ against any and all claims and for injury. Lessee will indemnify South Central Minnesota Youth For Christ for any costs incurred due to claims from anyone and all attorney fees and related costs in the use and return of the jumpy units should legal action occur.
